1. The stallion is collected at Gamberlee Australian Stock Horses, 50 Pine Lodge North Rd, PINE LODGE - SHEPPARTON, Victoria 3631.

2. Chilled semen will be delivered to the purchasers' nominated delivery address. This semen is supplied for the express purpose of creating equine pregnancies from owners' mare/s as specified in the **Gamberlee Purchase Agreement** only. The purchaser agrees to pay the following costs prior to delivery:
  - 2.1 \$200 booking fee, which is non-refundable and is deducted from the service fee.
  - 2.2 All Transport costs, as nominated by Gamberlee (see **Chilled Semen Order Form**) are to be paid as specified on said form, via Direct Bank Transfer, prior to the dispatch of the semen. The mare owner completes the **Chilled semen Order Form** and either emails to [gamberlee@hotmail.com](mailto:gamberlee@hotmail.com) or [leann.newton@gvequine.com.au](mailto:leann.newton@gvequine.com.au), or faxes it to (03) 5829 9307, with the delivery and Veterinarian details as required.

- 2.3 **Chilled semen:** no collection fees, can be transported anywhere in Australia, costing anywhere between \$100 - \$350, depending on where it goes and if it is same day delivery. A \$25 charge will occur if semen box is not returned via Australia Post within 7 days.
- 2.4 **Fresh semen:** no collection fees, \$70 per insemination and \$80 per dose of ovulating drugs. *Separate, added, costs apply with Gamberlee if the mare/s is to reside for a full cycle.*
3. Semen fees are non-refundable.
4. The Purchaser acknowledges that the Seller, Gamberlee, shall not be held responsible for any delays that may occur in relation to transport. The Seller, Gamberlee, does not indemnify the Purchaser for any losses that may occur as a result of any delay that may occur. The Purchaser acknowledges that it is their responsibility to obtain insurance cover for such events.
5. Cawdells Academy's service fee of **\$990**, is to be paid on the mare's 45 day positive pregnancy test. This service is sold with a LFG (Live Foal Guarantee). A non-refundable booking fee of **\$200** is to be paid in advance of insemination and will be deducted from the service fee (GST not applicable).
- 5.1 The LFG will only be activated once a veterinary report is sent to either Gamberlee or Goulburn Valley Equine Hospital stating that the mare has: lost the pregnancy, had a still born foal or the foal is born ill and dies before 24hrs of age.
6. Cawdells Academy's progeny can be registered with the ASHS.
